





Dr Rajendra Singh, Honorary Secretary of the Hindi Vidya Prachar Samiti in his speech said that our college has been always conscious about the role of quality and value based education in shaping the future of the students.

Key Note Address

Chief Guest: Dr Ganesh Anant Hegde, Adviser, NAAC Bangalore.

The keynote address was delivered by the Chief Guest Dr Ganesh Anant Hegde, Adviser, NAAC Bangalore. Dr Hegde in his keynote address the significance of the core values of NAAC. He explained the procedure as to how an educational institution can apply for NAAC accreditation. It is important for every institution undergoing accreditation process to visit the NAAC website and do detailed study in order the comprehensively understand the process and rules regarding accreditation. He discussed the seven stages involved in the entire process of accreditation. Dr Hegde discussed the meaning and significance of quantitative and qualitative metrics required to be submitted by institution undergoing accreditation. He informed about the different application criteria to be followed by the autonomous colleges and standalone institutions while applying for NAAC accreditation. Dr Hegde observed that the revised accreditation framework has given more weightages to the quantitative metrics in comparison to qualitative metrics. Hence it is important for the institution to have sound documentation practice while providing data validation and verification. In the light of the changing scenario NAAC had introduced new indicators like student satisfactory survey, alumni engagement and institutional distinctiveness. Dr Hegde suggested that every higher education institution applying for assessment and accreditation process must prepare executive summary of not more than five thousand words highlighting the main features of the institution.

Discussing about autonomous colleges Dr Hegde said that NAAC intends to make autonomous institutions dynamic in academics. The Criterion-1 indicators like curriculum design and development, academic flexibility, curriculum enrichment and feedback aims to judge the innovations of the autonomous institutions. He observed that teaching faculty must be clear while designing the curriculum and highlight the Programme outcomes, Programme specific outcome and course outcome. He also said the curriculum may be enriched by dividing the programme into core, elective and open elective course and introducing add-on courses and value-added courses. In his concluding remarks Dr Hegde emphasized on the need of higher education institutions to contentiously enhance and improve research, innovation and extension activities.

Technical Session 1

Dr Prasad in the first technical session elaborated on the Data Validation and Verification process (DVV), Student satisfaction survey and Peer team visit. Dr Prasad said DVV is the third stage in the accreditation process. At present, five external professional agencies have been hired by NAAC for the said purpose. The DVV partner verifies the extended profile questions, input for quantitative metrics, data templates and validity of the uploaded documents along with external web sources like AISHE, NIRF, UGC and institutional websites. The DVV team can raise queries in cases like lack of supporting documents, data provided in the SSR is not matching with cross checked with external web sources. The concerned institution should answer online queries raised in the DVV. Generally fifteen days timeline is provided for answering the queries. Dr Prasad stated that importance of referring to the Standard Operating Procedures document of the NAAC while creating the SSR or while answering the queries in the DVV. After the completion of DVV report the institution can checked the status report. It will inform the institution regarding the acceptance, recommendation or further clarification of the SSR.

Dr Prasad further explained the process of student survey report. The NAAC team conducts online survey of the students in order to elicit their responses pertaining to the teaching learning process. The students are randomly selected and surveyed. Confidentiality of their identities is maintained by the NAAC. The score of the survey is used only in the calculation of the final CGPA. Dr Prasad discussed the rules to be followed while entering and uploading the student's data.

Dr Prasad also spoke on the Peer team visit to the institution to be accredited. The main purpose of the peer team visit is to assess and verify the qualitative aspects of the self study report. The peer team in their visit examines the qualitative aspects, makes SWOT analysis and give suggestions to improve the academic and administrative quality of the institution. Dr Prasad further informed the Dos and Don'ts to be followed by the institution during the actual three day visit of the NAAC peer team.

Technical Session 2.1

Dr Seema Ratnaparkhi, in the second session, spoke on Criterion I Curricular Aspect. She stated there are eleven questions of which three are qualitative and seven are quantitative questions. Dr Ratnaparkhi said the effective curriculum delivery is a qualitative question for which institution has to submit descriptive information like allotment of duties, planning timetable and meetings between Principal and teachers. Institution should describe the content of the academic calendar along with list of co curricular, extracurricular activities and examination schedules. Institution must document information about their faculties involved in academic bodies of the universities. All documents related to appointment of teachers on academic bodies must be scanned and uploaded. On the academic flexibility indicator Dr Ratnaparkhi said institution should provide information about choice based credit system: programme, courses and elective in accordance with the data template. Further, institution should provide information about the certificate courses offered in last five years. Dr Ratnaparkhi spoke on the importance of the curriculum

enrichment indicator which is a qualitative indicator in which NAAC seek information about cross cutting issues related to professional ethics, gender, human values, environment and sustainability. Institutions have to provide information from the courses and syllabi that covers the above topics and provide documentary links. NAAC is also emphasizing how the experiential learning is integrated in the academic courses like field work, projects and internships. Dr Ratnaparkhi stressed on the importance of feedback on syllabus from important stakeholders like students, alumni and employers. Institutions can design their own feedback forms and do regular reviews. Dr Ratnaparkhi showed the samples of feedback forms to the viewers. The session ended with discussion with the participants.

Technical Session 2.2

Dr Nandini Vaz Fernandes in the second technical session dealt with Criterion II: Teaching, Learning and Evaluation. She said the purpose of the above criterion is to ensure institutions provide equal opportunity to the students, formulate policies and strategies to cater to the diverse group of students. NAAC seeks to understand through this criterion about the effective teaching learning experiences of the institutions that includes interactive instructional techniques, teaching learning pedagogies, evaluation modes and promotion of higher order thinking. Dr Fernandes observed that NAAC aims to ensure that institutions have adequate teaching infrastructure like total number available teachers, competency in teaching methods and ability to learn new educational technologies and pedagogical skills. Dr Fernandes further said the five key indicators of Criterion II – student enrollment and profile, catering to student's diversity, teaching learning process, teacher profile and quality, evaluation process and reforms, students performance and learning outcome and student satisfaction survey enables to understand the quality outcome of

the institution. Dr Nandini concluded by saying educational institutions must not only teach but develop the cognitive capacities of the students to develop their independent thought process.

Technical Session 3.1

Date: 17th January, 2021. Time: 10.00 am to 11.00 am

Resource Person: Dr. Surendra Thakurdesai, Associate Professor, G J College

Dr Thakurdesai in the technical session addressed the issues pertaining to Criterion 3. Dr Thakurdesai began his session by emphasizing on the importance of Standard Operating Procedures provided by NAAC. He called the SOPs the bible which will give us through idea of the various criteria and indicators. Speaking about the research grants received from governmental and non governmental bodies, he said, the duration of the grant period must fit within the assessment period of the NAAC cycle. The institution must be aware of the new rule that grants given by given by own trust or sister institution is not accepted by NAAC. He stated that while uploading information care must be taken to avoid errors which may be typographical or mismatch of information between the actual documents and what is uploaded or date and duration of the projects. Dr Thakurdesai observed that the sub criteria related Research, Innovation and Extension it is expected from the institution to have balance across the departments in matters of research. Institutions should promote all departments to undertake research activities so that balance statistical picture is reflected. Further, continuity in research is vital in order to have good score in the above criteria. Regarding documentation of seminars, conferences and workshops, Dr Thakurdesai said, it is important to upload the reports of the events conducted on the institutional website as soon as possible. According to him, mentioning the uploading date on the report is a good practice. Similarly individual faculty must also inculcate good documenting practices in matters related to articles published in journals and books. As per journal publication is concerned it is important to take screenshot of the website

and strategies enabling them to harness and optimize the utility of the information technology. Institutions should create database of the types of software, number of computers, sets of LMS, tevlevisions, CCTVs, recording instruments etc for reference. A separate office or tech desk of information technology can be maintained to administer the issues relating to information technology.

Speaking on Criteria 5- Students support and Progression Dr Sawant said an institution of higher education must be able to imbibe graduate attributes among the students. The success in the above endeavour automatically builds the brand image of the institution. He also emphasized the role of alumni in the brand building process. However, according to him, unlike the west India has not tapped the full potential of the alumni community. Further, he said, a robust student support system aims at augmenting the cognitive capacity, imparting technical and soft skills and inculcating human values in the students. Every institution must strive to support system for students on the lines of equity, access and excellence. Dr Sawant stated apart from classroom studies experiential learning is essential for the healthy personality development of the students and herein the role of curricular, extracurricular, community services and extension activities plays important role. Active participation in the above process will contribute to the nation building process.

Dr Usha Mukundan explained the Criterion 6 and Criterion 7. Criterion 6 covers the issue of Governance, Leadership and Management. Dr Mukundan said while filling the descriptive indicator about the vision and mission statement of the institution it is important to restrict within the given word limit. Highlighting the importance of the logo of the institution, she said, the logo is symbolic expression of the vision and mission of the college. She further claimed that vision and mission of any institution is must be dynamic to suit the changing demands of the educational system. The governance, institutional practices, administrative machinery and academic curriculum and teaching pedagogies must be reflective of the mission and vision statement. She further stated a well designed feedback system with two ways communication will be able to cater to needs and requirements of the stakeholders of the institutions. Speaking about e-governance system, Dr Mukundan said, many areas including online admission of students, payment of fees, payment of salaries of the staff, provident funds, conduct of examination, result processing, issuance of mark sheets etc comes within the ambit of egovernance. It is important to maintain records related to the above process like invoices of the software, contract documents with the vendors. On the criteria of faculty empowerment strategies, Dr Mukundan observed, institutions should make list of all welfare measures, financial assistance, training programmes, welfare fund etc. She emphasized on the role of Internal Quality Assurance Cell in institutionalizing the quality practices, strategies, action plans and feedbacks system.
